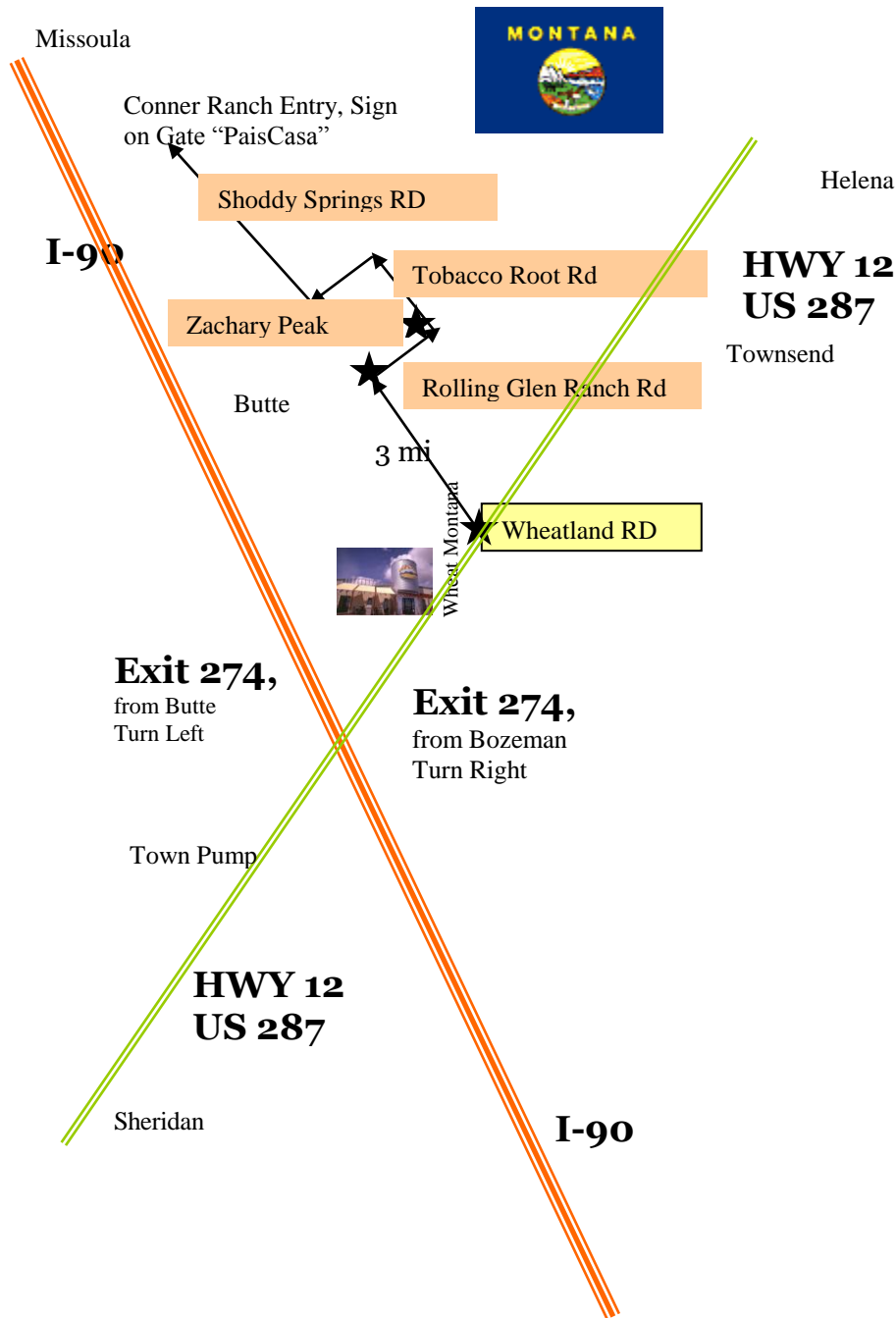

Directions to Conner Ranch North of Three Forks:

I-90 Exit #274 turn onto HWY 287, Hwy 12. Turn Left onto Wheatland RD. Travel west 2 miles to the intersection of Wheatland RD and Rolling Glen Road. Travel North on Rolling Glen Road 1.5 miles to the intersection of Rolling Glen Ranch RD and Tobacco Root RD (has rock pillars at entrance). Turn left and travel south on Zachary Peak Root RD for 0.5 miles to intersection with George Ridge RD. Turn right and travel west on George Ridge RD to cattle guard (start of Shoddy Spring RD). From the cattle guard stay on Shoddy springs RD traveling west for 2.3 miles to the entrance of Paiscasa Ranch.

Helena: HWY 12 turn right onto Wheatland RD (do not go past Wheat Montana Deli). Follow above directions from Wheatland RD.
